**WHEREAS**, Garden River First Nation currently provides its Chief and Council with an honorarium following the policy outlined at Section 1.6 of the January 30<sup>th</sup> 2018 Chief and Council Guidelines; and

**WHEREAS**, Garden River First Nation recognizes the need to fairly compensate its Chief and Council in a manner commensurate with the duties, tasks and responsibility of its office; and

**WHEREAS**, Garden River First Nation recognizes the need for transparency in how its Chief and Council are compensated;

**THEREFORE, BE IT RESOLVED**, Garden River First Nation revokes its current honorarium structure for Chief and Council effective September 19, 2023, shall strike out Section 1.6 of the January 30<sup>th</sup> 2018 Chief and Council Guidelines, and deems that Section 1.6 has been struck out; and

**THEREFORE, BE IT FURTHER RESOLVED**, Garden River First Nation adopts the salary structure for Chief and Council attached as Schedule 1 to this Band Council Resolution, to take effect as of the next elected council.
